### Friends of KSPS Board Meeting July 30th , 2020 – 4:30pm via Zoom

The meeting was called to order at 4:30pm by Chair Nancy Ledeboer

Motion to approve the consent Agenda including May 28, 2020 meeting minutes, GM report, Development report was approved (Samper/Hurst)

**Covid 19 pandemic report** – Gary reported on status and plans to keep everyone safe while conducting business.

May/June Financials - were presented by Treasurer Don Anderson

# FY 20-21 Budget – Don Anderson presented the budget that had been reviewed by the Finance Committee. Discussion followed with Q&A for staff and the committee.

**Consensus expressed:** Desire to track revenue and expenses in a way that aligns with the business plan; close monitoring of expenses and revenue as we move through the year given the pandemic and recession.

## Motion to include adding to the budget for a salary for a second Education staffer (Brooke/Scheiwiller)

Discussion: the position would begin in January; approx. \$40,000 in FY21 cost; \$60,000 annually; aiming to get half of costs covered by January via grants; we will probably also save on travel costs station-wide this year, roughly \$60,000.

Consensus was to table this until the September meeting.

Motion to approve the budget as presented was approved. (Hurst/Brooke)

## Chair Ledeboer, representing the Governance Committee, presented 5 nominees for board member in Group A for 3-year terms beginning in September:

New Members – Kim Lloyd, Addy Hatch Official term - 2 members who were elected earlier this year: Rosemary Selenger, James Alexie Beginning of Second term - Jeffrey Adams

### Officers were approved (Brooke/Selinger)

**Donald Summers, Atruist Partners,** presented on the revised business plan including the Civic Health Pillar.

**Retiree Recognition:** The board agreed to provide some recognition for the three KSPS retirees. Nancy will work with staff on arrangements.
