Consent Agenda

Workforce Development: Careers Northwest has a strong focus on outreach to rural schools. One of the Media Maker interns, who works remotely at a rural school, interviewed a bus driver for a job spotlight.

General Manager Update: Brooke Matson and Skyler Reep created a workshop for staff, which will be discussed at future meetings.

Jim Zimmer reported on the Exp '74 documentary (50 years in the making). This documentary will be available on May 11.

Marketing Update: Jonna Kelley described a partnership with a Canadian radio station. On the third Saturday of every month, KSPS volunteers at the Garland Theatre. Jonna has commissioned a custom-designed Civics Bowl T-shirt.
